3-4 Years	Golden Growers Developing independence, communication, structure, and school readiness.

### Included in School Fees

School fees include:

- structured educational programme
- supervised care
- outdoor play
- music appreciation
- worship
- drama activities
- holiday care
- swimming during summer where applicable
- age-appropriate developmental activities

## **Meals**

Children aged 2 years and older will receive:

- breakfast
- snacks
- lunch

Children younger than 2 years are required to bring their own meals, formula, bottles and feeding items depending on developmental stage and feeding requirements.

Parents must inform the school of:

- allergies
- dietary restrictions
- intolerances
- medical conditions

## **Registration & Development Levy**

An annual Registration / Development Levy is payable for each learner.

Annual Registration / Development Levy:

R1 500 per learner per year

This fee contributes toward:

- educational resources
- maintenance
- classroom development
- equipment
- operational improvements

This fee is:

- payable annually
- non-refundable
- required to secure enrolment

## **Payment Terms**

Fees are calculated on an annual basis but payments can be made on a monthly basis.

## **Monthly Payments:**

School fees are payable monthly over 12 months of the year.

Payments are due:

- from January to December
- payable in advance
- must reflect on or before the 5th day of date each month

## **Accepted Payment Methods**

Payments may be made via:

- EFT into the nominated account using the learner's name and first letter of surname as reference
- direct deposit
- approved debit order arrangements

Cash payments are discouraged where possible.

## **Sibling Discounts**

A sibling discount may apply for second and subsequent children enrolled at the school simultaneously.

Parents may contact the Finance Department for details regarding applicable discounts.

## **Late Payments**

Failure to pay fees on time may result in:

- reminder notices
- interest charges
- suspension of services
- withholding of reports
- refusal of re-enrolment
- legal recovery procedures

The school reserves the right to charge interest on overdue accounts, calculated daily from the due date until payment is received at a rate equal to prime lending rate + 2% to compensate for disruptions and collection costs.

Parents remain liable for:

- legal costs
- tracing fees
- collection charges
- administration costs related to recovery of outstanding accounts

## **Financial Clearance**

Financial clearance from previous schools may be requested where applicable.

The school reserves the right to decline enrolment where:

- significant outstanding fees exist at another institution
- financial information supplied is inaccurate or incomplete

## **Notice Period**

One full school term written notice is required when withdrawing a learner from the school.

Notice must be submitted:

- in writing
- to both the Principal and Accounts Department
- before the first day of the applicable term

Failure to provide the required notice may result in a cancellation fee equivalent to one term's fees.

## **Absenteeism**

There will be no fee reduction for:

- absenteeism
- illness
- holidays
- temporary absence
- extended leave

Fees remain payable to maintain the learner's placement within the school.

## **Late Collection Fees**

Children should be collected before closing time at 17:30.

Late collection fees:

- 17:30 – 18:00: R50 per incident
- After 18:00: R150 per incident

Repeated late collections may result in further administrative action.

## **Holiday Care**

Holiday care is available for enrolled learners during school holidays unless otherwise communicated. Holiday care is included in the normal school fees.

Operational hours during holiday periods:

06:00 am – 17:30 pm
